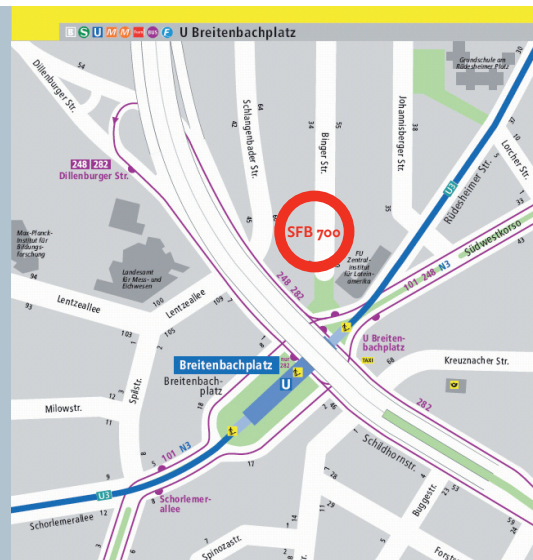

'Glocal' Practices of Security Governance in the Postcolony

Workshop, January 22-23 2010, FU Berlin

What is referred to as the cultural, the postcolonial, or the performative turn, amongst others, has brought concepts and methods from the humanities into political science that have challenged the Eurocentrism and top-down approaches to political and social processes deeply engrained in much of its theories and concepts. Approaches within the fields of Anthropology, Area Studies, and Sociology stress the often indirect and productive power effects of transferred knowledge and institutions. From the bird's view of formal institutions and governance agents, they turn to the processes of appropriation, subversion and contestation that translate and transform global models and incorporate them in the hybrid field of local practices.

In particular in the domain of security and policing studies, scholars have taken up these perspectives and developed new concepts and methods for an innovative, multidisciplinary security research agenda. Whereas the governance of security and policing could be perceived as being exclusively situated in the domain of 'hard' politics at first sight, innovative security governance research has stressed the importance of discourse and representation. The workshop focuses on security governance in its broad sense and looks at spaces in which security governance is predominantly shaped by external actors and knowledge in the Global South. Political rationalities and new forms of governance are being transferred by different means from the centres of late modern industrialised countries to 'areas of limited statehood'. Interested in the interaction between 'local realities' and 'global designs', this workshop invites researchers from the above mentioned research traditions to discuss theoretical insights and new conceptual and methodological tools for capturing the hybrid practices of 'glocal' security governance and the (new) spatial orders they produce.
